The storage area should also be dry and preferably do not exceed 50°C. It is advisable to process PP resin within 6 months after delivery. Conveying equipment should be designed to prevent production and accumulation of fines and dust particles that are contained in polymer resins. These particles can under certain conditions pose an explosion hazard. Conveying systems should be grounded, equipped with adequate filters and regularly inspected for leaks.
